

ORDINANCE NO. 2022- 25

AN ORDINANCE TO AUTHORIZE VILLAGE ADMINISTRATOR TO EXCEED SPENDING LIMIT AND SPEND UP TO \$25,030.00 TO PURCHASE A CURB AND VALVE BOX VACUUM SYSTEM WITH TRAILER, AND DECLARING AN EMERGENCY.

WHEREAS, the Village has an increasing need to clear curbs of leaves and debris, clean out storm drains, and remove debris from the sewer collection system to prevent blockages; and

WHEREAS, to better serve these maintenance and cleaning needs in a timely and efficient manner, the Village Administrator researched possible solutions and discovered a Curb and Valve Box Vacuum System, which was presented to the Public Services Committee; and

WHEREAS, the Public Services Committee determined that purchase of the Curb and Valve Box Vacuum is necessary to preserve the health, safety, and welfare of the Village; and

WHEREAS, the Village Administrator has obtained a quote of \$25,030.00 from HDSFM dba USABLUBOOK for a Curb and Valve Box Vacuum with a Trailer.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERBURG, OHIO:

Section 1. That the Village Administrator is hereby authorized to exceed her spending limit for a one time purchase up to a total expenditure not to exceed \$25,030.00 to HDSFM dba USABLUBOOK, PO Box 9004, Gurnee, IL 60031-9004, to purchase a Curb and Valve Box Vacuum System with a Trailer, a copy of said quote is attached hereto as Exhibit "A."

Section 2. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare, such emergency arising out of the need to address immediate maintenance and cleaning needs in the Village.

WHEREFORE, this ordinance shall take effect immediately upon passage and approval by the Mayor.
