RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR

WHEREAS, the Council for the Village of Centerburg, Knox County Ohio, in accordance with the provisions of law, has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1st, 2017; and

WHEREAS, The Budget Commission of Knox County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within, the ten mill limitation;

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Centerburg, Knox County, Ohio that:

SECTION 1. That the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and

SECTION 2. That there be and it is hereby levied on the tax duplicate of the Village of Centerburg the rate of each tax necessary to be levied within and without the ten mill limitation as set forth on "Schedule A" and "Schedule B" attached hereto and incorporated herein.

SECTION 3. That the Clerk of Council be and is hereby directed to certify a copy of this Resolution to the County Auditor of Knox County, Ohio.

WHEREFORE, this Resolution shall take effect at the earliest date permissible by law from and after its passage and approval by the Mayor.
