

RESOLUTION 2021-06

A RESOLUTION AUTHORIZING THE FISCAL OFFICER OF THE VILLAGE OF CENTERBURG TO APPLY FOR CORONAVIRUS LOCAL FISCAL RECOVERY FUND NON-ENTITLEMENT UNITS OF LOCAL GOVERNMENT (CLFRF) FUNDS UNDER AMERICAN RESCUE PLAN ACT (APRA) AND TO CREATE A NEW FEDERAL GRANT FUND BY BASED UPON THE GUIDELINES PROVIDED AND DECLARING AN EMERGENCY

WHEREAS, the American Rescue Plan Act of 2021 (ARPA) was signed into law by the President of the United States on March 11, 2021; and

WHEREAS, the Ohio General Assembly established a process for distributing funds provided by the “American Rescue Plan Act” to “Non-Entitlement Units of Local Government” (NEUs) under Coronavirus State and Local Fiscal Recovery Funds in H.B. 168 of the 134th General Assembly; and

WHEREAS, the Village of Centerburg is requesting its share funds form the Coronavirus Local Fiscal Recovery Fund Non-Entitlement Units of Local Government Fund.

NOW THEREFORE, be it resolved by the Council of the Village of Centerburg as follows:

Section 1: That the Fiscal Officer is hereby authorized to apply to Ohio Office of Budget and Management (OBM) for CLFRF Funds.

Section 2: The Fiscal Officer is further authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

Section 3: That the Fiscal Officer is authorized to create a new Federal Grant Fund for the said requested funds.

Section 4: This Resolution is hereby declared to be an emergency immediately necessary for the preservation of the public health, safety and welfare to ensure that the Fiscal Officer can obtain grants for the Village needs.

WHEREFORE, this Resolution is hereby declared to be an emergency and shall take effect and be in force on the earliest date allowed by law from and after its passage and approval by the Mayor.
