

**ORDINANCE 2014- 05**

**AN ORDINANCE TO AMEND ORDINANCE 2012-09 AMENDING SECTION 925.03 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF CENTERBURG RELATING TO THE RATE FOR SANITARY SEWER FACILITY SERVICES**

WHEREAS, Council determined that a modification to the rate structure for sanitary sewer charges is necessary to account for the costs, expenses and maintenance of providing said services to Village residents,

NOW, THEREFORE, be it ordained by the Council of the Village of Centerburg, Ohio:

Section 1. That Section 925.03 of the Codified Ordinances providing rates for Village sewer, as enacted by Ordinance 1991-7 passed on the February 11, 1991, and thereafter amended from time-to-time, and most recently amended by Ordinance 2012-09 passed on June 4, 2012, is hereby amended to read as follows:

Section 2. That all other provisions of relating to Village Sanitary Sewer not specifically amended herein shall remain in full force and effect.

WHEREFORE, this Ordinance shall take effect and be in force upon the earliest date allowed by law.

**EXHIBIT A - Sanitary Sewer System**

925.03 SEWER RATES

The rate of charges for sewer service is set forth below. The rate of charges for sewer service for any users outside the Village's municipal boundaries shall be an amount equal to 100% greater than the "Billing Charge" levied upon users within the Village municipal boundaries.

1) Current Billing Rates
