## ORDINANCE 2023-02

AN ORDINANCE TO AUTHORIZE THE VILLAGE ADMINISTRATOR TO IMPLEMENT CERTAIN PARKING CHANGES IN THE VILLAGE OF CENTERBURG ON CERTAIN DESIGNATED STREETS

WHEREAS, the Village Administrator, Mayor, and Council constantly receive recommendations from citizens regarding parking in the Village; and

WHEREAS, the Public Services Committee reviewed these recommendations in detail and proposes this Ordinance in effort to protect the safety and wellbeing of the Village of Centerburg; and

WHEREAS, Council has reviewed and considered said recommendations;

NOW, THEREFORE, be it Ordained by the Council of the Village of Centerburg, Ohio:

Section 1: That pursuant to Section 351 of the Codified Ordinances of the Village of Centerburg, the Village Administrator is hereby authorized and directed to do the following:

- A. Eliminate the handicap parking spot at the corner of Willis Street and W. Main Street and to further eliminate all parking in said location so the line of sight from Willis Street entering onto W. Main Street is not obscured.
- B. Establish a handicap parking spot on the east side of South Hartford Street at the intersection of W. Main Street beside the bank building.
- C. Establish a handicap parking spot on S. Clayton Street near the intersection of W. Main Street by the Library.
- D. Adding language to the stop light located at Preston Street and Main Street to include "no turn on red" during school hours.

<u>Section 2</u>: That upon this Ordinance becoming effective and the Village Administrator's installation of the proper signage or markings, where applicable, any violations be subject to penalties under Section 351.99 of the Codified Ordinances of the Village of Centerburg, as amended.

WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest period allowed by law after its passage and approval by the Mayor.
