

ORDINANCE 2017- 08

**AN ORDINANCE TO AMEND EXHIBIT A TO ORDINANCE 2016-16 TO CORRESPOND WITH THE VILLAGE BILLING OPERATIONS REGARDING WATER USAGE AND TO DECLARE AN EMERGENCY**

WHEREAS, Council determined that a modification to the rate structure for water usage is necessary to account for the costs, expenses and maintenance of providing said services to Village residents as addressed in Ordinance 2016-16;

WHEREAS, Exhibit A to Ordinance 2016-16 did not clearly reflect the distinction in rates between users within the Village and outside the Village in conformance with Village Ordinances;

NOW, THEREFORE, be it ordained by the Council of the Village of Centerburg, Ohio:

Section 1. That Section 925.04 of the Codified Ordinances providing rates for Village Water Usage, as enacted by Ordinance 1999-5 passed on the 5<sup>th</sup> day of April 1999, and thereafter amended from time-to-time, and most recently amended by Ordinance 2016-16 passed on November 7, 2016 shall be in conformance with Exhibit A to Ordinance 2016-16, which is hereby amended to clearly provide the rates for users within the Village and outside the Village.

SEE AMENDED EXHIBIT "A" FOR ORD. 2016-16 ATTACHED HERETO.

Section 2. That all other provisions of relating to Village water usage not specifically amended herein shall remain in full force and effect.

Section 3. That this Ordinance is declared to be an emergency, immediately necessary for the preservation of the public, health, safety, peace and welfare, such emergency arising from the need to ensure that the water usage rates are accurately reflected in the Ordinance for the benefit of all users.

WHEREFORE, this Ordinance is shall take effect and be in force immediately upon its passage and approval by the Mayor.

**EXHIBIT A - Water Usage Rates**

925.04 WATER USAGE RATES

The rate of charges for water service is set forth below. The rate of charges for water service for any users outside the Village's municipal boundaries shall be an amount equal to 100% greater than the "Billing Charge" levied upon users within the Village municipal boundaries. For the Purpose of this section, "bi-monthly" shall mean every two calendar months.

1) Bi-Monthly Billing Rates effective through December 31, 2016:
