ORDINANCE NO. 2022- |8|

TO REVISE REQUIREMENTS OF THE VILLAGE ADMINISTRATOR OF THE VILLAGE OF CENTERBURG AND HONOR PRIOR OPERS SERVICE AND DECLARE AN EMERGENCY

WHEREAS, Section 735.271 of the Ohio Revised Code provides "he shall become a resident of the village within six months after his appointment by the mayor and confirmation by the legislative authority of the village, unless his residence outside the village is approved by ordinance", and;

WHEREAS, Council does not wish to cause hardship for its new Village Administrator and desires to waive the residency requirement of ORC 735. 271; and

WHEREAS, Council has reviewed the wage, salary, and benefits for the new Village Administrator, Teri Wise, who has agreed to accept the position of Village Administrator upon the terms provided herein.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERBURG, STATE OF OHIO, THAT:

- Section 1. The Village Administrator, Teri Wise, will be paid a salary of \$65,000.00 per year, payable bi-weekly beginning the Village Administrator's first day of employment.
- <u>Section 2.</u> Council hereby approves the Village Administrator, Teri Wise, residing outside the Village limits as contemplated in ORC 735.271.
- <u>Section 3.</u> The Village agrees to honor Teri Wise's years of service as an Ohio Public Employee Retirement System employee with respect to Village vacation/leave policy and other personnel benefits as reflected in the Personnel Code.
- <u>Section 4.</u> The Village agrees to accept the transfer of 278.9 hours of sick leave to Teri Wise's sick leave account with the Village.
- Section 5. This Ordinance is determined to be an emergency, necessary for the immediate preservation of the public peace, health & safety, such emergency arising out of the necessity to provide a fair wage for the newly hired Village Administrator upon her first day of employment.
