ORDINANCE 2021-|| TO AMEND SECTION 351.99 VILLAGE PARKING PENALTIES

WHEREAS, the Village staff and officers have received complaints from residents about parking of vehicles for extended periods of time; and

WHEREAS, when reviewing the Village's codified ordinances, staff and the solicitor determined adding a definite time restriction was advisable; and

WHEREAS, the Village Council, after review and consideration, agrees and adopts the recommendation;

NOW THEREFORE, be it ordained by the Council of the Village of Centerburg as follows:

Section 1: That Ordinance 351.99 be adopted to read as follows:

- (a) Whoever violates any provision of this chapter and receives a parking ticket therefor may pay the ticket either by depositing the fine in the payment boxes located in the Village or by mailing the payment therefor to the Village of Centerburg, Box D, Centerburg, Ohio within 48 hours after the parking ticket was attached to his vehicle. (Ord. 1989-5. Passed 2-6-89.)
- (b) Anyone receiving a parking ticket for any violation under this chapter will be obligated to pay within 48 hours of the violation a fine according to the following schedule:
 - (1) Overtime parking in a two or four hour zone \$20.00
- (2) Improper parking such as in a yellow zone, no parking zone or in the wrong direction \$20.00.
 - (3) Parking in prohibited area such as an alley, walkway, or driveway \$30.00.
 - (4) Doubled parked \$30.00.
 - (5) Parked in excess of 48 hours \$30.00.
 - (6) Handicapped parking only \$50.00.
 - (7) Parking within 10 feet of fire hydrant \$30.00.
 - (8) Parking wrong side of street \$30.00.
 - (9) Snow removal \$30.00.
 - (10) Other \$30.00.

**If a parking ticket for any of the foregoing violations is not paid or postmarked within 48 hours, the fine will automatically double.

(c) Whoever violates any provision of this chapter and receives a parking ticket therefor and does not pay the ticket within 48 hours of the violation, shall be subject to an arrest warrant or summons and the penalty provided in Section 303.99.
