

ORDINANCE NO. 2015-20

**TO ACCEPT THE APPLICATION OF VILLAGE OF CENTERBURG
KYLE J. STROH, AGENT FOR ANNEXATION TO THE VILLAGE
OF CENTERBURG OF CERTAIN TERRITORY IN HILLIAR
TOWNSHIP CONSISTING OF THREE PARCELS OF LAND
CONTAINING 2.283 ACRES AND TO DECLARE AN EMERGENCY**

WHEREAS, a petition for annexation of certain territory in Hilliar Township to the Village of Centerburg was duly filed with the Knox County Board of Commissioners on July 10, 2015;

WHEREAS, the Village Council and Hilliar Township Trustees agreed to the terms of an Annexation Agreement for the annexation of said property pursuant to Village Resolution 2015-04 dated May 4, 2015 and Township Resolution 2015-0526 dated May 26, 2015;

WHEREAS, Village Council passed Resolution 2015-06 on June 11, 2015 consenting to Annexation and establishing the nature and extent of services to be provided;

WHEREAS, the petition was duly considered by the Board of County Commissioners of Knox County, Ohio, on August 6, 2015, and said Board has approved the annexation of such territory to the Village of Centerburg;

WHEREAS, the Board of County Commissioners certified a transcript of the proceedings in connection with said annexation with the map and petition to the Clerk of the Village of Centerburg who received the same on August 10, 2015;

WHEREAS, 60 days from the date of the filing have now lapsed in accordance with Section 709.04 of the Ohio Revised Code; and

WHEREAS, this Ordinance complies with the technical requirements of Section 709.04.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERBURG, OHIO:

SECTION 1. That the proposed annexation, as applied for in the petition of KYLE J. STROH, AGENT, which petition was filed with the Board of County Commissioners of Knox County, Ohio, on July 10, 2015, and which petition prayed for the annexation to the Village of Centerburg of certain territory adjacent thereto and hereinafter described, which petition was approved for annexation to the Village of Centerburg by the Board of County Commissioners on August 6, 2015, be, and hereby is, accepted. The territory annexed hereby is described in Exhibit A which is attached to this Ordinance and made a part hereof as though fully rewritten herein, and the certified transcript of the proceedings for annexation with an accurate map of the territory (see Exhibit B), together with the petition for annexation and other papers relating to the proceedings thereto of the County Commissioners are all on file with the Clerk of the Village of Centerburg and have been for more than 60 days.

SECTION 2. That the Clerk be, and hereby is, authorized and directed to make three copies of this Ordinance and to each of which shall be attached a copy of the transcript of proceedings of the Board of County Commissioners relating thereto and a certificate as to the correctness thereof. The Clerk shall then forthwith deliver one copy to the County Auditor, one copy to the County Recorder, and one copy to the Secretary of State, and shall file notice of this annexation with the Board of Elections within thirty days after it becomes effective.

SECTION 3: That this Ordinance is hereby declared to be an emergency, necessary for the preservation of the public health, safety and welfare for the Village to have said property owned by the Village within the Village boundaries.

WHEREFORE, this ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.


