

RESOLUTION 2016-08

RESOLUTION ACCEPTING KNOX COUNTY AUDITOR'S  
ORDER OF DIVISION OF THE CENTERBURG JOINT  
RECREATIONAL DISTRICT AND TO DECLARE AN EMERGENCY

WHEREAS, by Ordinance 2007-08, passed May 7, 2007, the Village of Centerburg approved participation in the Centerburg Joint Recreation District (CJRD); and

WHEREAS, Hilliar, Liberty, and Milford Townships previously withdrew from the CJRD, and the Centerburg Local School District was the last remaining party to do so; and

WHEREAS, Ohio Revised Code Sections 755.14, *et seq.* provides for the dissolution of joint recreation districts, and requires the County Auditor to ascertain, apportion, and order a division of the funds on hand, moneys and taxes in the process of collection, except for taxes levied for the payment of indebtedness, credits, and real and personal property, either in money or in kind, on the basis of the valuation of the respective tax duplicates of the withdrawing subdivision (the "County Auditor's Report"); and

WHEREAS, the same statute directs that when the number of subdivisions comprising a joint recreation district is reduced to one, the funds, credits and property remaining after apportionments to withdrawing subdivisions shall be assumed by the one remaining subdivision.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Centerburg, Knox County, Ohio that:

**SECTION 1.** Council approves the County Auditor's Report and findings therein, as such report is attached hereto as Exhibit "A" and incorporated herein by reference.

**SECTION 2.** The Mayor, or his designee, shall have all authority to communicate with the County Auditor regarding the conclusion of any business with the Centerburg Joint Recreation District, and to thereafter secure apportionment of any assets or payment of any liabilities related to this withdrawal.
