

RESOLUTION NO. 2020- 13

A RESOLUTION ACCEPTING COUNTY CORONAVIRUS RELIEF DISTRIBUTION FUNDS, CREATE A NEW FUND, AND AUTHORIZING AND DIRECTING THE FISCAL OFFICER OF THE VILLAGE OF CENTERBURG TO DISBURSE FUNDS BASED UPON THE GUIDELINES PROVIDED IN THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (CARES ACT) AND DECLARING AN EMERGENCY

WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act, 116 Public Law 136, (the CARES Act) was signed into law by the President of the United States on March 27, 2020; and

WHEREAS, the Ohio General Assembly established a process for distributing funds provided by the "Coronavirus Aid, Relief, and Economic Security Act" in H. B. 481 of the 133rd General Assembly (H. B. 481); and

WHEREAS, H. B. 481 requires subdivisions receiving funds under Section 1 of the act, to pass a resolution affirming that funds from the County Coronavirus Relief Distribution Fund may be expended only to cover costs of the subdivision consistent with the requirements of section 5001 of the CARES Act as described in 42 U.S.C. 601(d), and any applicable regulations before receiving said funds; and

WHEREAS, The Village of Centerburg is requesting its share of funds from the County Coronavirus Relief Distribution Fund.

NOW THEREFORE, be it resolved by the Council of the Village of Centerburg that the Council affirms that all funds received from the County Coronavirus Relief Distribution Fund pursuant to H. B. 481 be expended only to cover costs of the subdivision consistent with the requirements of section 5001 of the CARES Act as described in 42 U.S.C. 601(d), and any applicable regulations and guidance only to cover expenses that:

- (1) Are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19);
- (2) Were not accounted for in the Village Centerburg's most recently approved budget as of March 27, 2020; and
- (3) Were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.

FURTHERMORE, in compliance with H. B. 481, be it resolved by the Council of the Village of Centerburg that the Fiscal Officer take all necessary action to:

- (1) On or before November 20, 2020, pay any unencumbered balance of money in the Village of Centerburg's local coronavirus relief fund to the County Treasurer;
- (2) On or before December 28, 2020, pay the balance of any money in the Village of Centerburg's local coronavirus relief fund to the state treasury in the manner prescribed by the Director of the Ohio Office of Budget and Management; and
- (3) Provide any information related to any payments received under H. B. 481 to the Director of the Ohio Office of Budget and Management as requested.

FURTHERMORE, this resolution furthermore establishes the creation of a new fund called the Local Coronavirus Relief Fund pursuant to O.R.C. 5705.09(F).

WHEREFORE, This Resolution is hereby declared to be an emergency and shall take effect and be in full force immediately from and after its passage and approval by the Mayor.
