

ORDINANCE 2013- 02

**TO PROVIDE A COMPENSATION INCREASE
FOR THE VILLAGE ADMINISTRATOR AND CLERK-TREASURER
AND TO DECLARE AN EMERGENCY**

WHEREAS, Council has reviewed the wage, salary and benefits of the Village Administrator and Clerk-Treasurer and reviewed same for other employees per Ordinance 2013-___; and

WHEREAS, Council has determined it appropriate that the Village Administrator and Clerk-Treasurer have their pay adjusted for 2014 for services rendered on behalf of the Village;

WHEREAS, the Mayor has provided a recommendation to Council for pay adjustments for the Village Administrator and Clerk-Treasurer supported by job performance and economic or other relevant considerations in conformance with Ordinance 2012-03, Section 2.

NOW THEREFORE, be it ordained by the Council of the Village of Centerburg as follows:

Section 1: That the compensation for the Village Administrator and Clerk-Treasurer will be adjusted effective January 1, 2014 in conformance with the following:

The annual salary of the full-time Village Administrator shall be increased by one percent (___%) thereby increasing the salary to the sum of \$ _____, payable bi-weekly.

The annual salary of the Clerk/Treasurer shall be increased by two percent (___%) thereby increasing the salary to the sum of \$ _____ per year, payable bi-weekly.

Section 2. That a retroactive payment to adjust for payments already received prior to the enactment of this Ordinance shall be made by the Clerk Treasurer on the next regular payroll.

Section 3. That, except as specifically provided herein, the Village Administrator and Clerk-Treasurer remain eligible for all other applicable benefits and ancillary compensation provisions contained in the Employee Compensation Ordinance, Ord. 2013-___.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety in this Village, such emergency arising from the need to coordinate pay adjustments for all employees in conformance with Village payroll practices.

WHEREFORE, this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
