

ORDINANCE 2022- 216

TO AMEND ORDINANCE 2022-16, IN PART, TO AMEND THE UTILITY WORKER I POSITION AND TO INCLUDE A UTILITY WORKER II POSITION AND TO DECLARE AN EMERGENCY

WHEREAS, Ordinance 2022-16 adjusted the compensation ranges and annual salaries of the Village’s employees, which included a twenty percent (20%) base pay increase; and

WHEREAS, Council desires to re-classify Village employee Luke Ervin from a Utility Worker I to a Utility Worker II; and

WHEREAS, in order to effectuate the re-classification, Ordinance 2022-16 needs amended to reflect the vacancy in Utility Worker I and to include the filled position of Utility Worker II.

NOW, THEREFORE, be it Ordained by the Council of the Village of Centerburg, Ohio:

Section 1: That Section 2(B) as referenced in Ordinance 2022-16 shall be amended, in its entirety, to read as follows:

- B1. The hourly rate of the employee in the Utility Worker I position for 2022 was \$15.40 per hour and the range for the position was \$ 14.64/hour and \$20.44/hour. Effective October 1, 2022, the pay range for the Utility Worker I position shall be between \$17.57/hour and \$24.53/hour, payable bi-weekly.
- B2. The position Utility Worker II for 2022 was vacant. Effective October 1, 2022, the pay range for the Utility Worker II position shall be between \$21.35/hour and \$27.07/hour payable bi-weekly. The Village currently has one Utility Worker II employed.

The Utility Worker I's and II's pay rate effective October 1, 2022, were determined by the Village Administrator in conformance with the approved budget and certified by the Fiscal Officer and Village Administrator on Exhibit A attached hereto.

Section 2: That all other provisions in Ordinance 2022-16 shall remain unchanged.

Section 3: This Ordinance is determined to be an emergency, necessary for the immediate preservation of the public peace, health and safety, such emergency arising out of its necessity to provide a fair wage to Village employees.

WHEREFORE, this Ordinance is declared to be an emergency and shall take effect immediately upon passage.
