## **City Income Tax**

• The Village of Centerburg has a municipal income tax. Anyone who is a reside of, works in, or does business in the Village of Centerburg must pay taxes. Retired and disabled individuals are not required to pay municipal income taxes on their pension or disability payments. An exemption form is required for this status.
